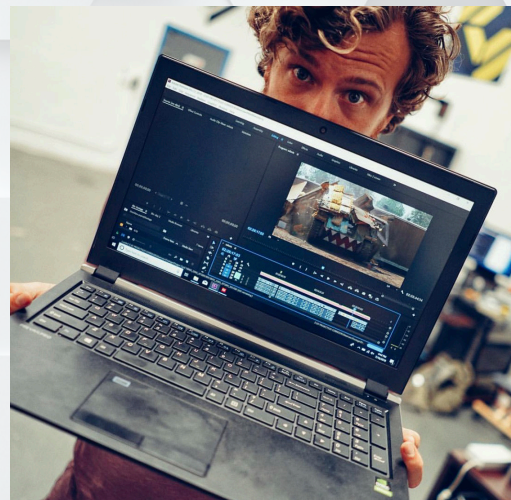




CORRIDOR DIGITAL TAKES THE PNY PREVAILPRO MOBILE WORKSTATION ON LOCATION - AND LOVES IT!

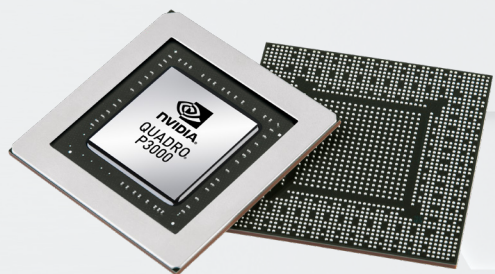

CHALLENGE

"One of the absolute best use cases for us is having a reliable workstation that can dump and begin an edit on location. We often have to travel for production and we can't tell you how nerve racking it can be waiting to offload footage from the camera card, hoping nothing goes wrong in that waiting period. Additionally, while traveling, we don't have access to our top line machines, which we typically have in our studio. The PREVAILPRO has enabled us to organize and even begin the edit of a project in our hotel which saves us a ton of time when we do get back into the studio."

"We were recently in Minnesota for an entire week on a big production. We were running multiple cameras and big stunts so we had to be very careful with all of our footage and how we logged it.
